PRAYER in W.P.No.3454 of 2024: Writ Petition filed under Article 226 of the Constitution of India praying to issue a Writ of Certiorarified Mandamus calling for the records in the sale proceedings in Ka.No.2052/2023/Tha2/ dated 13.12.2023 of the 7th respondent for the sale of Swarnavoor Village lake trees and to quash the same with consequential direction to the respondents to fix the fair price yield assessment as done by the 6th respondent till the compliance of the direction issued by this Hon'ble Court in W.P.No.25816 of 2014 order dated 05.01.2023 and thereafter to conduct a common public auction in transparent manner as per Tamil Nadu Transparency in Tender Act, 1998 to avoid the loss of Rs.37,69,622 to the Government.
