ORDER

This Writ Petition has been filed for direction to the respondents to disburse the Earned Leave calculated at the rate of 32 days per year from 01.01.1990 till the date of the petitioner's retirement together with interest at the rate of 18% p.a. for the delayed period from 31.03.2020 till the date of payment.

2. The learned Special Government Pleader appearing for the third respondent, on instructions, admitted their liability towards the petitioner as claimed in this writ petition. She further submitted that due to their present financial position, they are unable to pay the amount to the petitioner. She also submitted that the third respondent requires four months time to make the payment due to the petitioner excluding interest as claimed in the writ petition.

3. The learned counsel appearing for the petitioner would submit that four months time is a long period as the petitioner has not been paid since 31.03.2020, being the date of the petitioner's superannuation.

4. After giving due consideration to the rival submissions, this Court is of the considered view that eight weeks time can be granted to the third respondent to pay the admitted liability to the petitioner with regard to the disbursement of the E.L. calculated at the rate of 32 days per year from 01.01.1990 till the date of the petitioner's retirement, i.e., on 31.03.2020.

5. For the foregoing reasons, this writ petition is disposed of by directing the third respondent to pay the admitted liability to the petitioner pertaining to the disbursement of his E.L. calculated at the rate of 32 days from 01.01.1990 till the date of the petitioner's retirement together with interest at 18% p.a. for the delayed period from 31.03.2020 till the date of payment, within a period of eight weeks from the date of receipt of a copy of this order.

6. With the above direction, this Writ Petition is disposed of. No costs.
