3. The petitioner is working as a Supervisor in the respondents Department in the TASMACH Shop No.11584, Saram Village, Tindivanam Taluk, Villupuram District. While being so, on his request, the second respondent issued an order of transfer dated 24.01.2024, thereby transferred the petitioner to Shop No.11461, Marakkanam Town, Villupuram District as Additional Supervisor.

4. The only grievance of the petitioner is that already the petitioner is working as Supervisor and as such, he cannot be posted as an Additional Supervisor in TASMACH Shop No.11461, Marakkanam Town, Villupuram District, since the third respondent is junior to him. Because of the transfer order, no seniority will be changed and there will be anomaly between the petitioner and the third respondent. Only on the request made by the petitioner, he has been transferred to TASMACH Shop No.11461, Marakkanam Town, Villupuram District as Additional Supervisor.
