2. The writ petition is filed seeking direction against respondents 1 to 6 to take appropriate action and evict respondents 7 and 8 who have encroached the land vested with the fourth respondent.

3. Learned Government Advocate submits that survey would be conducted within four months from today, and if upon survey

encroachment is found, steps would be commenced for removal of the encroachment within one month thereafter.
