2. Heard the learned counsel appearing on either side and perused the materials placed before this Court.

It is seen that on the representation submitted the petitioner and other residents of Pukasagaram Village to lay road, the tender was floated and one contractor was awarded work order and the same was approved by the first respondent by its proceedings dated 07.02.2017. Thereafter, no work has been taken place and as such the petitioner submitted representation. Since the same was not considered, the petitioner filed the present writ petition with the above prayer.
