COMMON ORDER

The criminal complaints pending on the file of K.K.Nagar Police in Crime No.762 of 2019, Ashok Nagar Police Station in Crime No.262 of 2022 and Mambalam Police Station in Crime No. 674 of 2021 respectively have not been progressed and final report yet to be filed.
