ORDER

2. The Petitioner, who is the tenant of Shop No. 1 in M.G.R. Road Commercial Complex belonging to the Municipality of the Respondent, has filed this Writ Petition challenging the impugned Order in Na. Ka. No. 2094/2023/A2-1 dated 18.12.2023 issued by the Respondent fixing enhanced rent for the shop occupied by him.
