ORDER

2. The Petitioner, who is the tenant of Shop No. 12 in M.G.R. Road Commercial Complex belonging to the Municipality of the Respondent, has filed this Writ Petition challenging the impugned Order in Na. Ka. No. 2094/2023/A2-10 dated 18.12.2023 issued by the Respondent fixing enhanced rent for the shop occupied by him.
