ORDER

This Writ Petition has been filed challenging the order dated 01.04.2019 passed by the first respondent, thereby rejected the revision filed by the petitioner under Section 153 of the Tamil Nadu Co-operative Societies Act on the ground that the revision filed belatedly.

3. Though the petitioner approached the first respondent belatedly because of his poverty, he is also facing surcharge proceedings and criminal case. That apart, as against the order of dismissal, the petitioner may be given one more opportunity to agitate the appeal before the Revisional Authority.

4. Considering the above, the first respondent is directed to entertain the revision and pass orders on merits and in accordance with law.
