Heard Mr.L.Rangabass, party-in-person and Mr.A.Edwin Prabhakar, learned State Government Pleader assisted by Mr.K.Karthik Jagannath, learned Government Advocate for respondents 1 to 4.

2. The writ petition is filed seeking directions against respondents 1 to 4 to remove the encroachment on the public road in S.Nos.311/6 and 311/18.

3. Learned State Government Pleader submits that survey was conducted on 30.10.2023 and upon survey, encroachment has been
