2. According to the learned counsel appearing for the writ petitioner, after his retirement, the Trade Union and the Management has entered into a Settlement under Section 12(3) of the Industrial Dispute Act, on 04.01.2018, wherein, monetary benefits were conferred with effect from 01.09.2016.

3. Seeking the above said benefits, the petitioner has sent a representation to the respondents on 30.11.2023. Since there is no response, the present writ petition has been filed.

4. Heard the learned counsel appearing on either side and perused the materials available on record.
