ORDER

The writ petition has been instituted to forbear the respondents 1 and 2 from carrying out any activities in the petitioner's land bearing Ward No.2, Block No.2, T.S.No.45/1 in Plot No.New C-2, contrary to the approved layout in L.P./R(VD)4/75, in Lakshmipuram Town Planning Scheme area at Gandhi Nagar Colony in Thiruvannamalai Town, Thiruvannamalai Taluk, Thiruvannamalai District, within the jurisdiction of the Joint-II, Sub Registrar of Assurance, Thiruvannamalai in the Registration District, Thiruvannamalai.

2. The writ petition was instituted in the year 2012 and 11 years lapsed. A blanket injunction as such sought for in the present writ petition cannot be granted. The property right is subject to due process of law by
