The Writ Petition has been filed challenging the order of rejection dated 20.02.2024 issued by the First Respondent vide an E-mail dated 20.02.2024 in relation to the bid of the Petitioner in Tender bearing No. TCA/Fintech/2024/01 and to consequently direct the Second Respondent to consider the representation dated 20.02.2024 made by the Petitioner in that regard.

3. Learned Senior Counsel appearing for the Petitioner submits that after
