In these two writ petitions, the learned counsel for the petitioners filed memo dated 09.01.2023 stating that the sole petitioner in W.P.No.7281 of 2011 is no more and he is unable to contact the legal heirs of the petitioner therein. He also stated that inspite of his best effort, he is unable to contact the petitioner in W.P.No.7280 of 2011 and therefore, withdrawing his appearance in both the matters.

2.In view of the death of the petitioner in W.P.No.7281 of 2011 the writ petition stood abated. Accordingly, the writ petition is closed as abated leaving it open to the legal representatives of the deceased/petitioner in W.P.No.7281 of 2011 to file appropriate application to come on record and seeking restoration if they are so advised.

3.Insofar as W.P.No.7280 of 2011 is concerned, there is no appearance entered for the petitioner and there is none to prosecute the matter. In the circumstances, this Court is left with no other option except to dismiss the writ petition for non prosecution. Accordingly, W.P.No.7280 of 2011 is dismissed for non-prosecution.
