ORDER

This Writ Petition has been filed challenging the impugned order dated 04.12.2023 in Proceeding Na.Ka.No.5021/2023/Pa2 passed by the first respondent, thereby rejected the revision filed by the petitioner under Section 153 of the Tamil Nadu Co-operative Societies Act on the ground that the revision filed belatedly.

2. Heard the learned counsel appearing on either side and perused the materials available on record.

3. Though the petitioner approached the first respondent belatedly because of his poverty, he is also facing surcharge proceedings and criminal case. That apart, as against the order of dismissal, the petitioner may be given one more opportunity to agitate the appeal before the Revisional Authority.

4. Considering the above, the first respondent is directed to entertain the revision and pass orders on merits and in accordance with law. The petitioner is directed to file revision before the first respondent within a
