3.The petitioner is directed to co-operate with the Police for enquiry and the respondent Police shall conduct the enquiry keeping in mind the judgment in *Lalitha Kumari vs. Government of Uttar Pradesh* reported in **2013 (6) CTC 353**. On completion of the enquiry, the respondent Police shall take a decision regarding the further course of
