passed by the District Revenue Officer, Tiruttnai on 25.10.2023, wherein the sub-division made in the survey Nos. 183/17 and 183/21 pertaining to Muni Reddy and Krishna Reddy was cancelled due to the pendency of the suit in O.S.No. 72 of 2015.
