2. The learned counsel for the petitioner submitted that it would suffice if a direction is issued to the 1st respondent to consider the petitioner's representation dated 06.10.2023 within a time as may be fixed by this Court.

3. Mr.S.J.Mohamed Sathik, learned Government Advocate takes notice for the respondents 1 to 3. Since no adverse order is being passed against the respondents 4 to 8, notice to the respondents 4 to 8 is dispensed with.

4. Having regard to the submissions made by the learned counsel on either side and since this writ petition is filed seeking a simple writ of mandamus to consider the petitioner's representation, this Court without expressing any opinion with regard to the merits of the case, directs the 1st respondent to consider the petitioner's representation dated 06.10.2023 and issue notice to the petitioner, respondents 4 to 8 herein, adjacent land owners of the four boundaries of the subject property and also to the interested parties/rival claimants/objectors/aggrieved parties if any, as the

case may be and after issuing notice to all the parties, conduct enquiry in
