2. The learned counsel appearing for the petitioner submitted that while pending the writ petition, entire work has been completed by the respondents without following the guidelines issued by the Government of Tamil nadu.

3. Considering the submissions made by the learned counsel appearing for the petitioner, the third respondent is directed to conduct enquiry in this regard and take appropriate action as against the erred officials as expeditiously as possible.
