The grievance of the petitioner is that the second respondent has put up an illegal superstructure in Old Survey No.83/1C1, New Survey No.83/15, Plot No.40, Kamraj Nagar, Mathur, Madhavaram Taluk, Chennai-68. In this regard, the petitioner sent representations to the first respondent on 11.1.2020 and 1.4.2024. As the said representations did not evoke any response, the present writ petition is filed.

2. Considering the narrow scope of the prayer made in the writ petition, without going into the merits of the matter, the writ petition is disposed of with a direction to the first respondent to
