The Revision petitioner herein is the plaintiff. Respondents are the defendants. This revision petition is filed challenging the order dated 03.09.2019 passed in I.A.No.298 of 2017 in O.S.No.346 of 2009 by the District Munsif, Sankrapuram.

Today, when the matter is taken up for hearing, the learned Additional Government Pleader appearing for the respondents 2 and 3 viz., Thasildar, Sankarapuram Town and Taluk and The District Collector, Villupuram District, would submit that the main suit in O.S.No.346 of 2009 itself was dismissed for default on 05.12.2023.
