It is the grievance of the petitioner that the petitioner has given an application through online on 10.01.2024 to measure his property by paying necessary charges. However, the same has not been considered by the respondents. Hence, the present Writ Petition.

Considering the limited relief sought for in this writ petition, the respondents are directed to consider the online application of the petitioner dated 10.01.2024 and pass appropriate orders on the same after giving notice to the neighbouring land owners and any other interested persons, within a period of two months from the date of receipt of a copy of this order.

6. With the above direction, this writ petition is disposed of. No costs.
