2. The learned counsel for the petitioner submitted that it would suffice if a direction is issued to the respondents to consider and dispose of the petitioner's representation dated 28.11.2023 within the time as may be fixed by this Court.

3. Mr.T.Arun Kumar, learned Additional Government Pleader takes notice for the respondents 1 to 6. Since no adverse order is being passed against the 7th respondent, notice to the 7th respondent is dispensed with.

Having regard to the submissions made by the learned counsel on either side and since this writ petition is filed seeking a simple writ of mandamus to consider the petitioner's representation, this Court without expressing any opinion with regard to the merits of the case, directs the 3rd respondent to issue notice to the petitioner and to the 7th respondent herein and also to the rival claimants/interested parties/objectors if any, as the case may be and conduct enquiry in the manner known to law and pass

orders on merits and in accordance with law, within a period of eight weeks from the date of receipt of a copy of this order.
