2. The Writ Petition has been filed to restrain the First to Third Respondents herein from in any manner handing over the administration of the Temple of the Second Respondent to the Fourth Respondent.

3. In view of the order dated 05.02.2024 in M.P. No. 16 of 2023 passed by the First Respondent confirming the earlier order dated 14.10.2014 in M.P. No. 37/2013/B1 appointing the Fourth Respondent as the Hereditary Trustee of the Temple of the Second Respondent to the Fourth Respondent, Learned Counsel for the Petitioner seeks permission of the Court to withdraw the Writ Petition with liberty to challenge the said order with consequential reliefs and he has made an endorsement to that effect in the court record.
