3.Learned Additional Public Prosecutor appearing for respondents 1 & 2 submitted that the representation / complaint made by the petitioner is not available with the 2nd respondent. Learned Additional Public Prosecutor further submitted that if fresh representation / complaint is made by the petitioner, the same will be enquired and a decision will be taken with regard to providing police protection.

4.Considering the submissions made by learned Additional Public Prosecutor, there shall be a direction to the petitioner to give a fresh representation / complaint to the 2nd respondent. The 2nd respondent, on
