COMMON ORDER

The learned counsel appearing for the third respondent submitted that as a matter of fact 50% of the earlier services of the petitioner in W.P.No.32621 of 2013 has been taken into account and by an order dated 22.03.2017 pension has also been granted to the petitioner and nothing further remains for adjudication in this writ petition. Similarly in W.P.No.32622 of 2013 the petitioner has passed away, but, however, 50% of the services as prayed for in the writ petition has been taken into account and an order of grant of family pension dated 13.11.2017 has also been passed. Therefore, nothing remains for further adjudication in this writ petition also.

2. The learned counsel appearing for the third respondent had also produced the said orders dated 13.11.2017 & 22.03.2017. Therefore, nothing survives in these writ petitions and these writ petitions have become infructuous.
