said Society and disciplinary proceedings have been initiated against the 4th respondent by the 3rd respondent for certain alleged irregularities.

3. Mr.L.P.Shanmugasundaram, learned counsel for the petitioners submitted that the charges against the 4th respondent have been proved and imposed with the punishment of stoppage of 3 years increment with cumulative effect.

4. However, these petitioners have filed this petition seeking a writ of mandamus, to direct the respondents 1 to 3 to impose a major punishment against the 4th respondent. Even if the petitioners happen to be the members of the Society, they are third parties to the employment contract between the 4th respondent and the respondents' Society.

5. Mr.P.Sathish, learned Additional Government Pleader for the respondents submitted that the 4th respondent has filed Revision Petition under Section 153 of the Tamil Nadu Cooperative Societies Act, 1983 and the same is still pending.



6. Whatever may be the case, these petitioners have got no *locus standi* to question the quantum of punishment that was been imposed by an employer against his employee. Hence, this Writ Petition is not maintainable and the same is **closed**. No costs.
