ORDER

[Order of the Court was made by J.NISHA BANU,J.]

This Writ Miscellaneous Petition is filed to recall the order dated 11.01.2024 made in W.P.No.34178 of 2023 and permit the Bank to file its counter.

2.We have specifically pointed out vide order dated 11.01.2024 in W.P.No.34178 of 2023 that the Hon'ble Apex Court and various High Court have time and again stressed that verification after retirement is a wasteful exercise and would be purely academic. In similar circumstances, in SLP(C) No.24458 of 2019 dated 03.03.2023, the Hon'ble Apex Court has held as follows:

“It is submitted that the respondent No.1 who served in the Railways has superannuated on 28.02.2022 and therefore, the exercise in this case would largely be academic on the aspect of whether she belonged to the claimed Scheduled Tribe category.

Considering the above, we deem it is appropriate to order for closure of the proceedings.

Accordingly, the Special Leave Petition stands disposed of.”
