2. In view of the above submission, the Writ Petition stands **closed**.

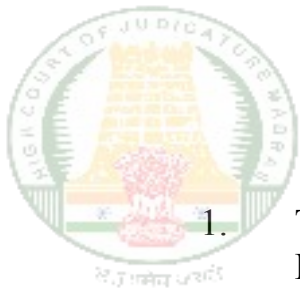
