3.Learned Additional Public Prosecutor appearing for respondents 1 & 2 submitted that the representation made by the petitioner is not available with the 1st respondent. Learned Additional Public Prosecutor further submitted that if fresh representation is made by the petitioner, the same will be enquired and a decision will be taken with regard to providing police protection.
