Accordingly, all these petitioners have been restored in their original place of their seniority. Further, the revised Seniority of Tahsildar Panels from 2008 to

2022 has been published on 11.03.2024. Accordingly, these petitioners names appeared in the revised seniority panel.

3. Recording the said submission these writ petitions are closed. It is also made clear that the petitioners are entitle for monetary and service benefits from the date of their arrival from the post of Deputy Tahsildar to Tahsildar.

4. In view of the above, these writ petitions are closed. Consequently, connected miscellaneous petitions are closed. No costs.
