ORDER

When the matter was taken up for hearing, it was submitted by the learned counsel for the petitioner that the matter may be closed leaving it open to the petitioner to challenge any individual promotion order if he is aggrieved. She has also made an endorsement to that effect:

“The writ petition challenges the circular pursuant to which CAS promotions are made. Since many years have passed and there are many persons promoted under the impugned circular, the petitioner may not be in a position to implead each of them. As such, the writ petition may be closed leaving it open to the petitioner to challenge any individual promotion order if he is aggrieved.”
