Having regard to the submissions made by the learned counsel on either side and since the Writ Petition is filed seeking a simple Writ of Mandamus to dispose of the revision, this Court without expressing any opinion with regard to the merits of the case, directs the 1st respondent to issue notice to the petitioner and the respondents 4 to 6 herein and the parties in the revision and after giving opportunity of hearing to all the parties, pass orders on merits and in accordance with law and dispose of the revision dated 19.01.2024, within the time as prescribed in the circular No.R1/2005632/2022 dated 17.07.2023 issued by the Commissioner of Land Administration, from the date of receipt of a copy of this order.
