When the matter was taken up for hearing, the counsel on either side agreed that they have no objection if the proceedings in H.M.O.P.No.270 of 2023 now pending before Sub Court at Tambaram and H.M.O.P.No.152 of 2023 pending before Sub Court, Attur are withdrawn and transferred to Family Court at Chennai.

In the light of the opinion expressed by both sides, H.M.O.P.No.270 of 2023 pending before Sub Court at Tambaram and H.M.O.P.No.152 of 2023 pending before Sub Court, Attur are withdrawn and transferred to Family Court at Chennai. The transferee Court need not insist upon the appearance of the parties for all the hearings. The parties are required to be present only for indispensable hearings, and for other procedural hearings, they shall be represented through their counsel.
