The petitioner has given a representation to the second respondent on 07.02.2024, seeking to survey and fix the boundary stones in respect of the land in S.No.185/5 in Ariyur Naddu Village, Kollimalai Taluk, Namakkal District, measuring an extent of 2 cents. The petitioner has also paid requisite fees through E-challan on 05.02.2024. Since the second respondent has not considered the same till date, the present writ petition is filed.
