2. Heard the learned counsel for the petitioner and the learned counsel for the 2nd Respondent.

3. During the course of hearing, the learned counsel for the

petitioner represented that, one of the respondents died and petitioners are not furnishing necessary information to take steps inspite of several remainders. Petitioners are not coming forward to prosecute the case and she is not cooperating to proceed with the case.
