ORDER

The petition has been filed seeking modification of the order of the learned XV Metropolitan Magistrate, George Town, Chennai in Crl.M.P.No.2421 of 2024 dated 13.03.2024, while granting bail to the petitioner, the learned XV Metropolitan Magistrate, George Town, Chennai had directed to deposit a sum of Rs.20,000/-, and produce two sureties out of the two sureties one surety to be a blood surety.

2.The learned counsel for the petitioner stated that the petitioner has found it difficult to produce blood sureties and also to deposit the cash as directed.

3.Taking into consideration, the condition imposed by the learned XV Metropolitan Magistrate, George Town, Chennai to deposit is modified to Rs.10,000/- and condition to produce two blood sureties is modified to two local sureties for a like sum to the satisfaction of the XV Metropolitan Magistrate, George Town, Chennai.
