ORDER

The petitioner herein claiming title and right over the property situated in Survey No.155 extending 0.55 acres and Survey No.152/2 measuring 1.06 acres in Theetalam Village, Madurantakam Taluk, Chengalpattu District is before this Court seeking police protection for measuring the said land, since the 3rd respondent is objecting the attempt of measuring the land and consequential fencing.

On notice, the 3rd respondent appeared through Learned Counsel and submitted that the petitioner herein under the guise of measuring his land, has trying to encroach upon the property of the 3rd respondent and his relatives. If the petitioner wants to measure his land situated in S.Nos.155 & 152/2 as per the title document, he has no objection.
