ORDER

revision under Section 153 of the Tamil Nadu Co-operative Societies Act, 1983 before the jurisdictional Joint Registrar of Co-operative Societies/Deputy Registrar of Co-operative Societies.

2. In that view of the matter, this Writ Petition is dismissed as not maintainable, however, with liberty as aforesaid. As and when the petitioner file any revision, the same may be considered by the appropriate authority on merits and in accordance with law. No costs.
