ORDER

(Judgment of the Court was made by J. NISHA BANU, J.)

The above CMP has been filed to condone the delay of 1973 days in filing the Writ Appeal against the order made in WP.No.8466 of 2017 dated 24.09.2018.

2. Writ Appeal SR has been filed to set aside the order dated 24.09.2018 made in WP.No.8466 of 2017 by this Court.

3. There is undoubtedly an inordinate delay in the filing of the Writ Appeal. There is a delay of more than 5 years in preferring the appeal. The petitioner/appellant has utterly failed to show sufficient cause to condone the enormous delay of 1973 days in filing the Writ Appeal. On an overall view of the grounds taken in the Civil Miscellaneous Petition and submissions made by learned counsel for appellant, would make it clear that there is no

error apparent on the face of the record warranting review of order dated 24.09.2018 made in W.P.No.8466 of 2017.
