2. Heard the learned counsel appearing for the petitioner and the learned Additional Government Pleader appearing for the respondents and perused the materials available on record.

3. A settlement came to be made in view of the settlement arrived between the parties before Lok Adalat.

4. In pursuant to the settlement arrived at between the parties in Lok Adalat on 29.06.2022, the Labour Court, has passed the Award on 11.07.2022.
