ORDER

By consent of both parties, this writ petition is taken up for final disposal at the stage of admission itself.

2. This Writ Petition has been filed seeking a direction to the respondent to consider the representation of the petitioner dated 20.12.2023.

3. The facts of the case is that the petitioner has entrusted with the work of providing 150 nos of Solar Street light with pole and also to convert the existing conventional lights to Led street light. The petitioner also completed the work but the payment was not done by the respondent. Due to which the petitioner has given a representation to the respondent on 20.12.2023, but the same was not considered. Hence this petition.

4. The learned counsel for the petitioner submitted that it would be suffice if this Court issues a direction to the respondent to consider the petitioner's representation dated 20.12.2023 and pass orders.
