The Writ Petition has been filed challenging the selection notification dated 09.12.2014 issued by the second respondent, pertaining to recruitment to the post of Assistant Professor in Periyar College of Arts and Science at Edappadi, Periyar College of Arts and Science at Mettur, Periyar College of Arts and Science at Pennagram, Periyar College of Arts and Science at Pappireddipatty and for a consequential direction to direct the second respondent to issue fresh notification.

Today, when the matter is taken up for hearing, the learned counsel appearing for the petitioner and the learned Additional Government Pleader appearing for the first respondent submitted that the recruitment pursuant to the notification dated 09.12.2014 has been completed in the year 2014 itself
