3. Heard learned counsel for the petitioners and the learned Special Government Pleader appearing for the respondents and perused the materials

The case of the petitioners is that they had purchased the subject property by way sale deeds of the year 1971 and 1978 and they are in possession and enjoyment of the property ever since the date of purchase. The grievance of the petitioner is that though they have given a representation to the respondents on 29.02.2024 to survey their lands by metes and bounds, the respondents have not taken any action to survey their lands. Hence, the present Writ Petition.

5. Considering the limited relief sought for in this writ petition, there shall be a direction to the respondents to dispose of the representation of the petitioners dated 29.02.2024 to survey the land of the petitioners after giving notice to the neighbouring land owners and any other interested persons and within a period of two months from the date of receipt of a copy of this order.

6. With the above direction, this writ petition is disposed of. No costs.
