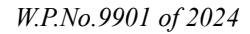

ORDER

This Writ Petition is filed seeking a direction to the respondent Nos.1 to 4 to consider the representation of the petitioners, dated 18.03.2024.

2. The petitioners are seeking to include the qualification of P.G. Diploma also in Sanitary Inspector course in Gandhigram Rural Institute as an essential qualification/eligibility for the post of Sanitary Inspector under the Urban Local Bodies.

3. When the matter came up for admission, *Mr.A.Leeban*, learned Counsel for the petitioners would submit that for effective implementation of the *Tamil Nadu Urban Local Bodies Act, 1998* as well as the *Urbal Local Bodies Rules, 2023*, the Government has issued G.O.(Ms).No.77, dated 14.06.2023, in and by which, it has constituted committees to look into various issues.

In view thereof, this Writ Petition is disposed of by directing the Committee constituted under G.O.(Ms).No.77, dated 14.06.2023 to consider the representation of the petitioners, dated 18.03.2024 in accordance with law. In any event, the decision taken by the Committee shall be communicated to the petitioners within a period of six weeks from the date
