2. The petitioner submitted a application on 06.04.2023 with a request for sub-division of petitioner's property, which is pending without consideration.

3. Heard learned counsel for the petitioner and the learned Special Government Pleader appearing for the respondent and perused the materials available on record.

4. By consent of both parties, this writ petition is taken up for final disposal at the admission stage itself.

5. Considering the limited relief sought for in this writ petition, the respondent is directed to consider the application of the petitioner dated 06.04.2023 and pass appropriate orders on the petitioner's application for sub-

in accordance with law, after giving notice to the neighbouring land owners
and any other interested persons. Such exercise shall be completed within a
period of two months from the date of receipt of copy of this order.

6. With the above direction, this writ petition is disposed of. No costs.
