2. This writ petition is filed to direct the second and third respondents to dispose of the application E-Challan No.20230925009407 filed by the petitioner dated 25.09.2023 to survey the land of the petitioner and measure his property and fix its boundaries.

3. Heard learned counsel for the petitioner and the learned Special Government Pleader appearing for the respondents and perused the materials available on record.

The case of the petitioner is that the subject agricultural land has been settled in favour of the petitioner by his parents by way of registered settlement deed dated 30.06.20215 and the revenue records have also been mutated in the name of the petitioner. It is the grievance of the petitioner that he had made an application to survey his land and also paid necessary fee. But the second and third respondents have not taken any action to survey his land. Hence, the present Writ Petition.
