This writ petition is filed to direct the first and second respondents to consider the petitioners representation dated 13.03.2023 to grant patta in the name of the petitioner school in respect of the lands situate in Survey no.7/46 7/47 and 680/3 measuring about 270 Sq.m 1670 Sq.m and 1100 Sq.mtr in Ammapettai and padavalkalvai Village, Anthiyur and Bhavani Taluk respectively Erode District.

3. Heard learned counsel for the petitioner and the learned Special Government Pleader appearing for the respondents and perused the materials available on record.

Considering the limited relief sought for in this writ petition, the second respondent is directed to dispose of the representation of the petitioner dated 13.03.2023 for issuance of patta to the petitioner on its own merits and in accordance with law within a period of two months from the date of receipt of a copy of this order.

6. With the above direction, this writ petition is disposed of. No costs.
