This writ petition is filed to direct the third respondent to issue Patta in the name of the petitioner in respect of the land comprised in Survey No.386 situated in Kangeyanallur Village, Katpadi Taluk, Vellore District by considering the report submitted by the Revenue Inspector of Katpaid Taluk bearing Aathimu/155/2023 dated 21.03.2023 within the time limit specified by this court.

WEB COPY 4. The case of the petitioner is that her husband purchased the subject property in the year 1974 and since then they are in peaceful possession and enjoyment of the property. The grievance of the petitioner is that though the Revenue Inspector has recommended for issuance of patta in the name of the petitioner, patta has not been given in her name. In this regard she has given a representation to the third respondent and no action has been taken in this regard. Hence, the present Writ Petition.

5. Considering the limited relief sought in this Writ Petition, the third respondent is directed to consider the representation of the petitioner dated 23.11.2023 and pass Orders on the same as per law, after giving opportunity to the persons who claim right over the property within a period of two months from the date of receipt of a copy of this Order.
