2. Mr.N.Baskaran, learned counsel on record for the revision petitioner and Mr.Arun C.Mohan, learned counsel for respondent are before this Court.

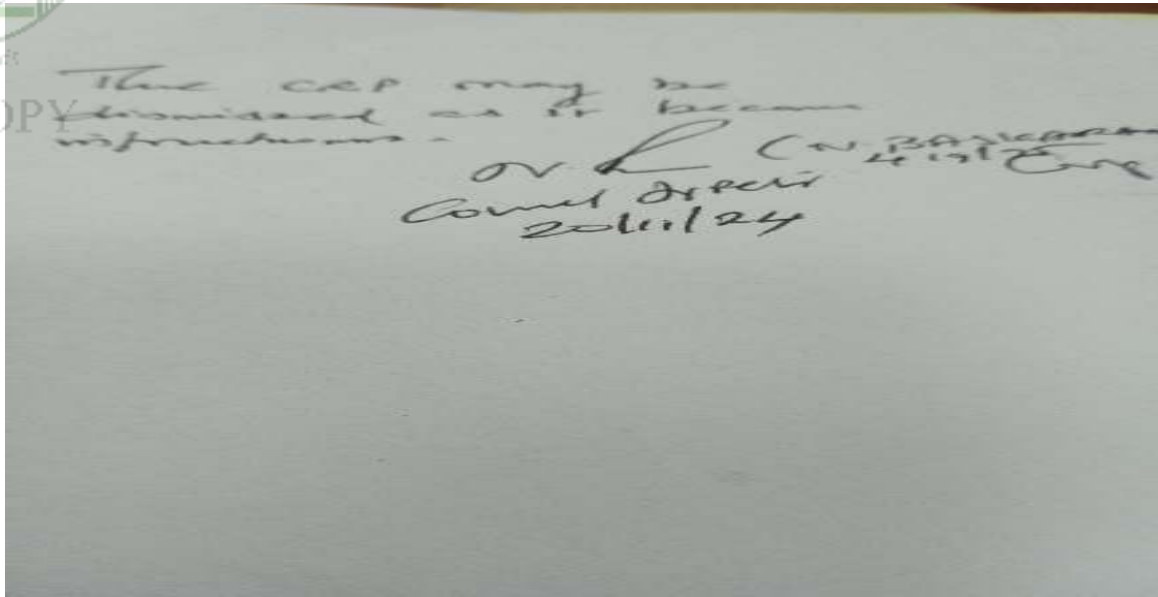
